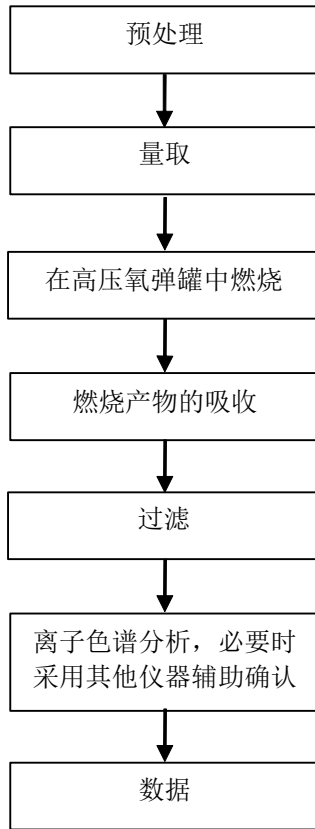

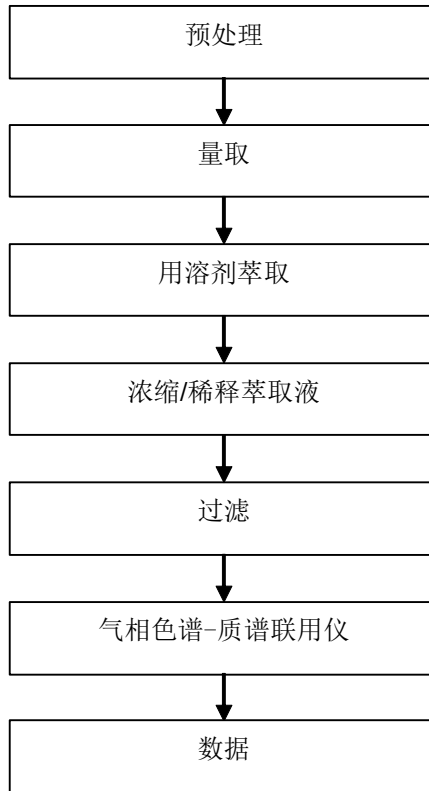

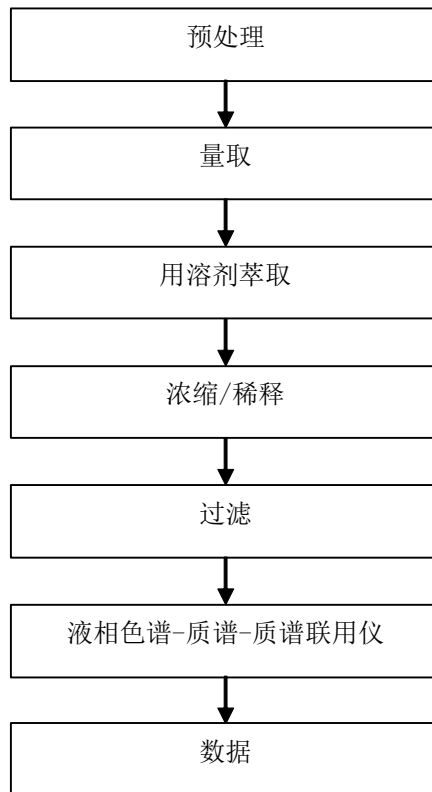

PBBs/PBDEs 测试流程图



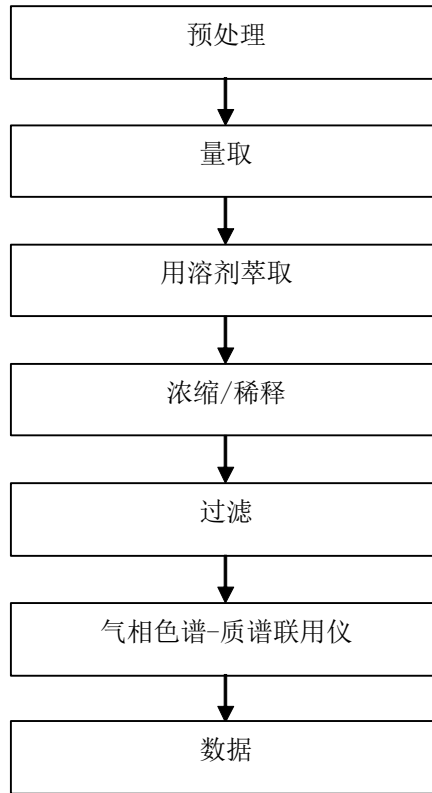

PFOS/PFOA 测试流程图



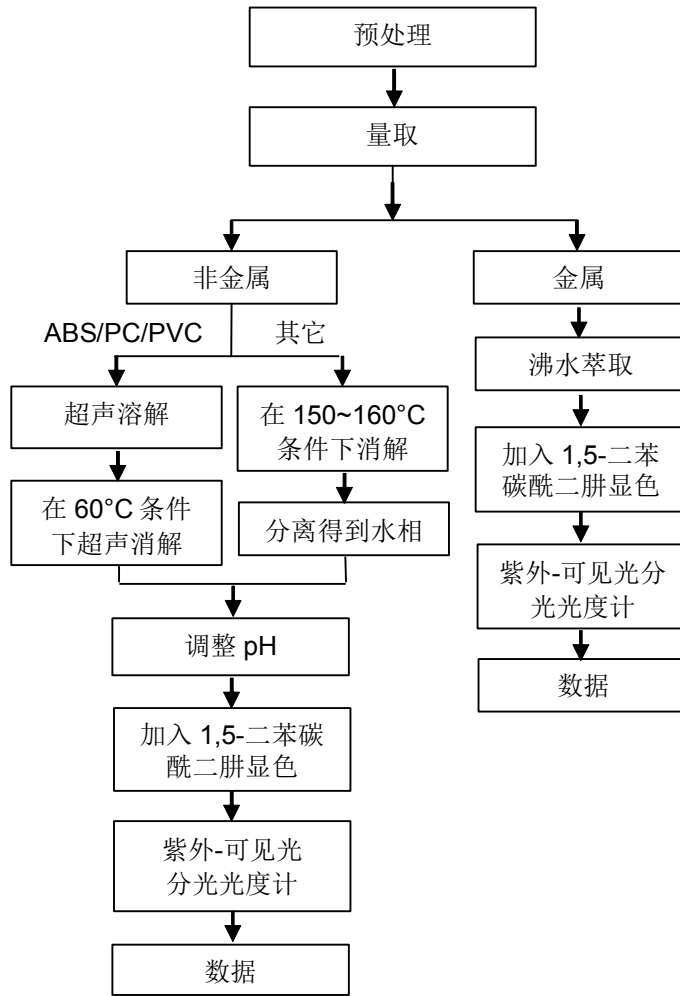

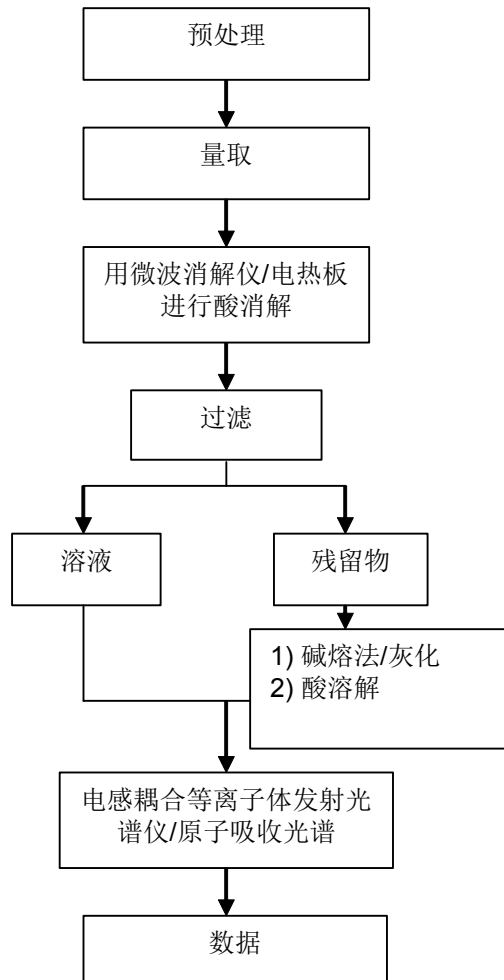
